Liberator Tube Color Change

Going forward customers may receive part number 14224654 as either the current black color or a white color. This is the length of tube over the breathing coil near the relief/economizer assembly. The two colors are interchangeable in terms of service needs.

Eclipse 5® Preventative Maintenance Kit Part Numbers

Part number 5022-SEQ includes all the replacement parts needed to perform preventative maintenance on Eclipse® units. Previously, the PM kit included two different product filters, which allowed it to be compatible with every model Eclipse® units produced with the HEPA filter internal to the product tank and units with the disk type HEPA filter external to the product tank. We will no longer supply HEPA Filter 6986-SEQ since the previous style product tank was discontinued 2011. If you require the External type HEPA filter you will need to purchase the new product tank assembly, PN SP4378-SEQ.



FAA Guidelines

- Q.) Why can't I find my portable oxygen concentrator listed on the FAA site?
- A.) On May 24, 2016 the Federal Aviation Administration (FAA) issued a final rule to replace the existing process by which the Agency approves portable oxygen concentrators (POC) for use on board aircraft in air carrier operations. This final rule replaced the existing FAA approval process in Special Federal Aviation Regulation (SFAR) No. 106 to currently allow passengers to use a POC on board an aircraft if the POC satisfies the acceptance criteria and labeling requirement stated in the final rule. The labeling requirement only affects POCs intended for use on board aircraft that were not previously approved prior

to May 24th ruling for use on aircraft by the FAA2. The FreeStyle Comfort is the only CAIRE product that has been released after the May 24, 2016 ruling and is therefore not included on the SFAR 106 listing. The FreeStyle Comfort is labelled according to FAA labelling requirements.
