AirSep is willing to grant You a limited license to use the Materials solely for use in the following publication (if applicable): \_\_\_\_\_ (the “Publication”), for the following purpose: \_\_\_\_\_ (the “Purpose”) under the terms and conditions of this License.

1. User understands and agrees AirSep (or its affiliates) owns all right, title and interest in and to the Materials, including derivative works. Under no circumstances shall User, as a result of this License, obtain any ownership interest or other right, title or interest in or to any intellectual property rights or Materials of AirSep or its affiliates, whether by implication, estoppel or otherwise.
2. AirSep hereby grants User and User accepts, a non-exclusive, revocable, non-transferable, non-sublicenseable, royalty free license to use, reproduce, display, transmit and distribute Materials in the Publication solely for the Purpose.
